6. The unit shall ensure that, "In case of revision of consent fee by the Government, the unit shall remit the difference in amount within one month from the date of notification. Failing to remit the consent fee, this



consent order will be withdrawn without any notice and further action will be initiated against the unit as per law".

The unit shall not use "use and throwaway plastics" or as plastic sheets used or food wrapping, spreading on dining table etc., plastic carry bags, plastic bags, plastic covers and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises. Instead unit shall encourage use of eco friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, jute bag etc.,

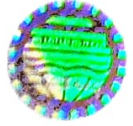
